2. Summary of Status:

Brief description of the status of implementation of the SSFA at the time of reporting and progress towards achieving SSFA's objective

The implementation of the project started early in 2016 as we anticipated some activities since we received the grant agreement letter in September 2015. The equipment required for DNA genotyping (a real-time PCR machine) has been purchased and set up in the genetic laboratory in Libreville. 30 carcass samples and 458 ivory samples have been collected and preliminary tests of quality have been run. The laboratory technician has been trained in ivory sampling, DNA extraction and analysis, as well as safe laboratory practices. However, timelines of transfer of funds and suppliers and the implementation of new regulations by the Gabonese government for the physical inspection of imported goods before their shipment substantially delayed the procurement of laboratory consumables. A delay of six weeks in the implementation of the project is expected due to the postponement of some activities.

Therefore we hereby request the UNEP approval for a six-week extension of the implementation period (end date stipulated in the agreement: 15 September 2016; requested end date: 30 October 2016).
